To be eligible, the student must be a child of any Louisiana workers who have been killed or permanently and totally disabled in an accident compensable under a state or federal Workers' Compensation Act or law. This means that the parent is on disability or was killed in a work related accident. The scholarships are to assist with expenses at any two or four year college.

Completed applications must be returned and postmarked to LBF Kids' Chance Committee by March 1, 2010.

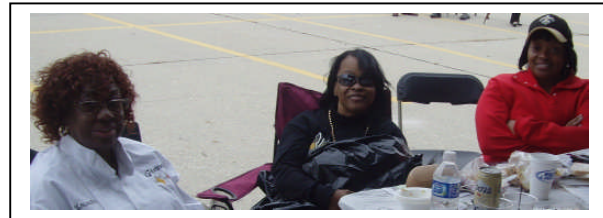
